ELIGIBILITY

The **ArtCityPC: Local Artist Expo** is a Show & Sale presented by Bay Arts Alliance that is open to artists residing in Bay County and the surrounding areas.

MEDIA & SPECIFICATIONS

1. The **ArtCityPC: Local Artist Expo** is meant to showcase all forms of 2D art including, but not limited to photography, painting, illustration, and mixed media.

ALL ARTWORK MUST BE FOR SALE.

2. **ARTWORK WILL BE ACCEPTED AT THE CENTER FOR THE ARTS ON NOVEMBER 26 - 30, 2019** during normal business hours. Tuesday - Saturday 10am - 5pm.

3. The framed size of the artwork must be no larger than 60" tall or wide. Exceptions can be made depending on the space available.

4. **ALL ARTWORK MUST BE READY TO HANG** with standard picture framing wire securely attached to the backside.

5. Bay Arts Alliance reserves the right to reject any artwork which it deems unsuitable or inappropriate for this show & sale.

6. Artists must pick up any unsold artwork between January 11-16, 2020. If no arrangements with the staff have been made, all artwork still remaining in the building after January 16, 2019 will be subject to a storage fee \$5/day.

SALES AND COMMISSION

Bay Arts Alliance will take a commission of 30% for all works sold during this event. The price listed on the entry must include this commission. Bay Arts Alliance will handle all sales.

LIABILITY

It is recommended that artists carry their own insurance. All reasonable care will be taken with all artwork. Bay Arts Alliance, its officers, employees, directors, anyone connected with the exhibition, will not be responsible for loss or damage however caused. Artist agrees to hold Bay Arts Alliance harmless for the commercial value of their artwork. Bay Arts will indemnify the artist for the materials cost up to \$200 on a case by case basis. Your entry into this exhibition constitutes agreement with these terms. Bay Arts Alliance will not be responsible for damage incurred during transit or after the show ends.

PUBLICITY

Your entry into this exhibition constitutes permission for the Bay Arts Alliance to photograph or reproduce any and all works in the exhibit for the purposes of advertising, publicity and/or archival records, without compensation to the artist.
